- 8. New Business
  - a. Player Liaison Committee Reorganization Jim Reed
    - i.   - c. Deb Heisey will also check to see if there is coverage in the insurance policy for something like this. However, we are pretty sure it is blanket coverage with regard to liability. The rates are based on the amount of money that we normally handle.
  - d. Jim's decision regarding how to handle this is not a change to the membership status. If someone feels that action would need to be taken in this respect, the By-Laws or Code of Ethics would need to be followed. That states that a letter with a signature is required along with a request for a special meeting of the Board and Jim would determine a time and a place for such a meeting.
- b. The names were pulled for the Buddy Program by Kristen Simon and were mated to those on the list based on a first come, first served basis.
- c. Deb Heisey and Jim McNaught made a motion to not give away a membership at the tables on the concourse. The entire Board approved the motion.
- d. Meeting date changes were suggested for the July Board and General Meetings due to conflicts.
