- 4. Kelley Breniser and Lori Baxter made the motion to approve the minutes of the June 7, 2010 Board meeting. The entire Board approved the motion.

- b. Charitable Mindy Reed
 - i. The Orioles Advocates will be at the stadium on July 31 for their collection drive in Lancaster.
 - ii. Deb Heisey is working to put together a meeting with the Humane League to see how we can develop a partnership and will seek volunteers to join this initiative at the next general meeting.
 - iii. The United Way has a website set up for the Day of Caring. Mindy will review it to see if there is something that we are able to help with and address it at the General Meeting.
 - iv. Community Homeless Outreach Center Sunday, July 25th, there will be a motorcycle ride through Lancaster County and will end at the stadium. The Board voted, via electronic vote) to assist Tom Fasnacht (the gentlemen who coordinates the Project for the Needy) with staffing the event at the Stadium.
